### **Contract**

### **Lawrence County Educational Service Center and The Rock Hill Local School District**

Lawrence County Educational Service Center (ESC) and the Rock Hill Local School District (RHLSLSD) enter this Contract for the purpose of operating extended learning programs at Rock Hill Elementary, Rock Hill Middle School, and Rock Hill High School (FY22-FY23) for the purpose of addressing learning loss associated with the COVID-19 pandemic.

#### **Terms of Service and Confidentiality**

RHLSLSD requests that the ESC operate after school programs based on agreed standards, guidelines, and in cooperation with the Superintendent, Treasurer, Building Principals, and Director of Instruction.

Both school districts have a mutual right to privacy and confidentiality in their service relationship. All documents will be kept confidential and will not be shared or released with any other person, entity, or agency without expressed written consent from both parties.

#### **The Lawrence County Educational Service Center will:**

- Work with district to provide a seamless program between day school and after school
- Provide a team of experts to implement the program
- Perform all fiscal operations in accordance with program guidelines
- Invoice the district for those services rendered on a quarterly basis after the initial invoice for startup cost
- Provide all fiscal records upon request
- Report audit results on annual basis

#### **The Rock Hill Local School District will:**

- Inform ESC staff of required program guidelines and accountability measures
- Obtain ODE approval for budget
- Provide access to facilities, transportation, staff, students, and district resources (as available)
- Assist program consultant and site coordinator in recruitment of staff
- Maintain district liability insurance coverage throughout grant period
- Compensate Lawrence County Educational Service Center for services rendered and expenses incurred per approved program guidelines and established budget. In addition, the ESC will be paid 5% of the total expenditures for the program for administrative cost.
